(A) Accounting Policies

1. Income:

The Trust follows Cash system of accounting and recognizes income and expenditure on cash basis.

2. Fixed Assets:

- a) Fixed Assets are accounted at cost of acquisition inclusive of inward freight, duties and taxes and incidentals related to acquisition.
- b) Depreciation on fixed assets is charged on Written Down value basis at the following rates :

i)	Building		10%
ii)	Furniture & Fixtures	-	10%
iii)	Plant & Machinery	-	15%
iv)	Vehicle	-	15%
v)	Computer Equipment	-	60%

(B) Notes on Accounts

- a) The Current Assets and Loans & Advances, in the opinion of the Board of Trustees, are approximately of the value shown if realized in the ordinary course of business.
- b) The figures for the previous year have been regrouped and re-arranged wherever necessary.
- c) The trust is having a land of 40 Bigha at Champapura, Kalwar. The land has been revalued as per current DLC rate.
